



FELLOWSHIP SQUARE HISTORIC MESA

The Next Normal for Independent Living Phase II

Older adults are at high risk for complications from the Coronavirus (COVID-19). Fellowship Square Historic Mesa will implement a phased re-opening of our campus amenities. The safeguards that have been implemented will remain until the phase where lifted. Timing changes, additional precautions and restrictions are at the discretion of the Executive Director. Fellowship Square Historic Mesa will continue to adhere to the Coronavirus guidelines from the Centers of Disease Control and Prevention (CDC), AzDHS and Maricopa County Department of Public Health. Residents may continue to self-quarantine as they deem necessary. Even with all the precautions, risk of contracting the virus remains.

Precautions that will remain in place until further notice **through all phases:**

- Staff will continue to follow facemask protocol, have a daily brief health screening and continue infection control protocols.
- Proper social distancing will be implemented where practical. .
- Enhanced cleaning and disinfecting of common areas will continue.
- Visitors, Staff and Residents are reminded by signage at entrances to stay home if they have symptoms of respiratory illness.
- Self-Quarantine for 14 days is required if your doctor has requested residents self-quarantine **OR** tested positive for COVID19 **OR** have been to a high risk location (i.e. hospital, nursing home, emergency room or rehab). Residents are required to notify staff so extra precautions can be taken for the safety of staff and residents.
- East and West gates will remain locked.

The following introduction to Phase II will be implemented and is subject to change as best practices emerge:

Phase II transition to adding back services:

Continued from Phase I

- June 1st - Grand Beauty Shop Open with restrictions
- June 1st - Small Group Activities by reservation with restrictions
- June 8th - Grand & Center Pool open by reservation with restrictions

June 10, 2020, Wednesday

- Non- essential visitors are allowed provided they wear a mask or cloth face covering and pass brief health screen. Visitors are only allowed from parking area to resident apartment. Visitors are not allowed in common areas. **Also note that screening will now be done at the delivery drop zone (not the lobby).** For everyone's health safety please limit visitors as much as possible. Precautions will remain until further notice.

June 15, 2020, Monday

- Package delivery will be allowed to the residents' apartments by delivery service; if packages are dropped at the door without a signature required. Delivery personnel will be asked to wear a mask or cloth face covering.

Restrictions that continue:

- Grocery delivery services requires personal contact and therefore will continue at the drop zone during posted times.
- Meal service will continue with delivery only.
- Limited individual transportation continues to essential medical only.
- Community gyms remain closed with channel 1960 programming.
- Community rooms and common areas open to scheduled activities only
- Resident communications will continue to be delivered to apartments.
- Housekeeping continues once per month
- No volunteer lead programs
- Country Store Deliveries will continue Monday – Friday
