# DONATE TO SENIORS IN NEED While Reducing Your State Income Tax

Arizona's Charitable Tax Credit program allows taxpayers like you to designate their state income tax withholdings as a donation to a Qualifying Charitable Organization (QCO) of your choice.

Christian Care Foundation is a not-for-profit 501(c)(3) organization that has three ALTCS (Arizona Long Term Care System) Assisted Living properties which provide medical care to underserved seniors, and each location qualifies as a donation recipient for the Arizona Tax Credit.

You have the option of redirecting your tax money (paid to the State) so that it provides high-quality medical care for our low-income seniors, who rely on government assistance for their essential Assisted Living care.

# **Tax Credit Summary**

#### **Donation Amount:**

Single filers can donate up to \$400; married filing jointly can donate up to \$800

#### Where it Goes:

100% of donation goes to care provided in our skilled nursing center

#### **Tax Credit:**

You receive a dollar-for-dollar Arizona income tax credit

#### **Arizona's Charitable Tax Credit Overview**

- 1. The Arizona Department of Revenue recognizes three of Christian Care's Assisted Living properties as Qualifying Charitable Organizations:
  - Christian Care Nursing Center (at Fellowship Square Phoenix)
  - Christian Care Mesa III

     (at Fellowship Square Historic Mesa)
  - Christian Care Mesa Manor IV (at Fellowship Square Mesa)
- 2. See designated tax credit amounts above. (A tax credit donation to one of our senior care properties is separate from and in addition to Arizona's Foster Care Tax Credit or a Public/Private School Tuition Tax Credit.)
- 3. No need to itemize deductions on your Arizona tax return.
- 4. For tax filing purposes, use Arizona form 321. (Info Needed: legal property name above & the associated QCO code)
- 5. Deadline for donations April 15th of each year.
